## 5.2 CPP Partnership with Dunnville District Heritage Association

Costing for the pathway signage was discussed; with the current budget (County grant, donations, sponsorships) approximately four sign per year may be completed. The project is expected to span two years. Also discussed – the inclusion of the Dollier and Galinee plaque (funded by the Jackman Foundation, slated for installation in Port Maitland) may be included within the project scope.

#### 5.4 Canfield Black Settlement Project (Windecker Road Films, Graeme Bachiu, Producer)
