Pharmacy Review – Jelte Schaafsma

Jelte joined the meeting to discuss the Pharmacy funding changes in Long Term Care. Medical Pharmacies is restructuring and is therefore pulling back on some of the services that have previously been provided to us. The restructuring should not affect the care and services provided to our residents.

The pharmacy will receive a flat fee for every resident receiving prescriptions in a long-term care home rather

than paying for each individual prescription that's issued. The pharmacy fee will be based on the number of beds in the home. Medication deliveries for the home are Wednesday nights from 5:00 pm - 7:00 p.m. and provides a week's work of medication. If medications are ordered by our physician throughout the week, the pharmacy will make a special delivery to ensure that the resident starts the new medication as soon as possible.
