

## THE CORPORATION OF HALDIMAND COUNTY

By-law Number 2182/20

### Being a by-law to amend By-law 1942/18 to regulate the rates of speed in Haldimand County - Caledonia

**WHEREAS** Section 27(1) of the *Municipal Act*, 2001, S.O. 2001, c. 25., as amended, authorizes municipalities to pass by-laws in respect of a highway under its jurisdiction;

**WHEREAS** in accordance with the Act, the Council of the Corporation of Haldimand County enacted the By-law 1942/18 to regulate different rates of speed for motor vehicles driven on a highway or portion of a highway in Haldimand County;

**AND WHEREAS** the Council of the Corporation of Haldimand County now deems it expedient to amend By-law 1942/18 with respect to the maximum rates of speed in Caledonia,

**NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:**

1. **THAT** Schedule "A" of By-law 1942/18 be amended by adding the following:

Patterson Drive	Arnold Marshall Boulevard	MacLachlan Avenue	50 km/h
Sumac Drive	Fleming Crescent	Thompson Road	50 km/h
Thompson Road	Fleming Crescent	McClung Road	50 km/h

2. **THAT** this by-law shall take precedence over any other by-law with which is inconsistent.
3. **AND THAT** this by-law shall come into force and take effect when signage applicable to this provision has been installed and is on display.

READ a third time and finally passed this 16<sup>th</sup> day of June, 2020.
