### **PURPOSE OF POSITION:**

Reporting to the Project Manager, Forestry; Facilities, Parks, Cemeteries and Forestry Operations Division, the incumbent will:

Assist with the care and maintenance of horticulture gardens, parks, cemeteries and forestry.

### **EDUCATION & EXPERIENCE:**

- Must be enrolled in a post secondary school on a full-time basis.
- University or college education with a preference given to candidates that have completed a minimum of one year studies in Environmental Sciences, Horticulture, Landscape Architecture or Landscape Design.
- Current relevant experience considered an asset.

- Familiarity with basic horticulture and landscape design concepts and practices.
- Must have Class G2 drivers license (minimum).
- Current First Aid/CPR Level 3 certification considered an asset.
- Ability to work in a team environment, accept and follow verbal and written instructions, complete duties to an
  acceptable level of quantity and quality with minimal supervision and follow all or Haldimand County Health and
  Safety Policies and Procedures.
- Must be motivated, hardworking individual able to complete tasks on time.
- Proven initiative and attention to detail.
- Must be able to follow directions, work independently and with minimal supervision.

- Duties will require climbing, lifting, balancing, kneeling, stooping, walking and handling of materials.
- Majority of work will be conducted outdoors in all weather conditions (rain, heat, etc.).
- Other duties as assigned.
