NOTICE OF FILING OF ADDENDUM LAKE ERIE INDUSTRIAL PARK WASTEWATER TREATMENT SYSTEM

THE STUDY

In 2011, the County of Haldimand completed a Schedule 'C' Municipal Class Environmental Assessment (MCEA) Study for the Lake Erie Industrial Park (LEIP) Wastewater Treatment System. The study was undertaken to identify alternative solutions to address long-term wastewater treatment and servicing capacity needs for the LEIP, the US Steel (Stelco) LEIP lands, and the surrounding settlements of Townsend and Jarvis.

Due to the lapse of time since filing of the 2011 Environmental Study Report (ESR) for public review, an Addendum to the ESR has been completed. The Addendum was completed in accordance with the MCEA process (October 2000, amended 2007, 2011 & 2015), which is approved under the Ontario Environmental Assessment Act.


The purpose of this ESR Addendum is to review the planning and design process followed, in order to ensure that the project and the mitigating measures are still valid given the current planning context.

THE PROCESS

By this Notice, an Addendum is being placed on the public record for review in accordance with the requirements of the MCEA process. Subject to comments received as a result of this Notice, and the receipt of all necessary approvals, the County of Haldimand intends to proceed with detailed design and construction as documented in the Addendum.

In addition, a request may be made to the Ministry of the Environment, Conservation and Parks for an order requiring a higher level of study (i.e. requiring an individual/comprehensive EA approval before being able to proceed), or that conditions be imposed (e.g. require further studies), only on the grounds that the requested order may prevent, mitigate or remedy adverse impacts on constitutionally protected Aboriginal and treaty rights. Requests on other grounds will not be considered. Requests should include the requester contact information and full name.

Requests should specify what kind of order is being requested (request for additional conditions or a request for an individual/comprehensive environmental assessment), how an order may prevent, mitigate or remedy those potential adverse impacts, and any information in support of the statements in the request. This will ensure that the ministry is able to efficiently begin reviewing the request.
